### Description

Multranol 9133 is a 160-molecular-weight polypropylene oxide-based triol used in the production of solid and microcellular polyurethane elastomers, spray elastomers, and adhesives. As with any product, use of Multranol 9133 polyol in a given application must be tested (including field testing, etc.) in advance by the user to determine suitability.

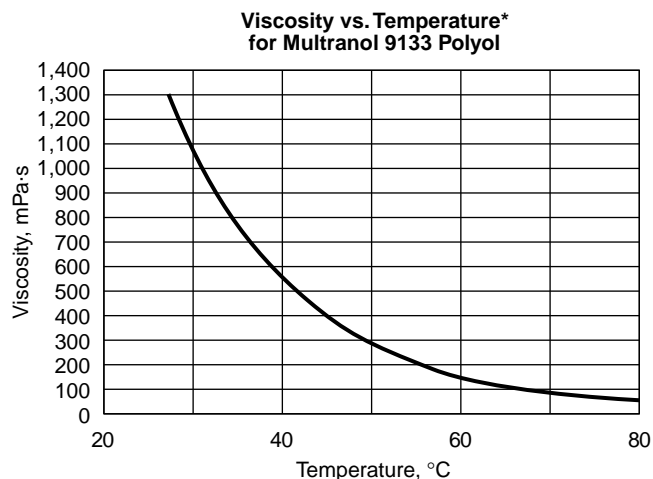
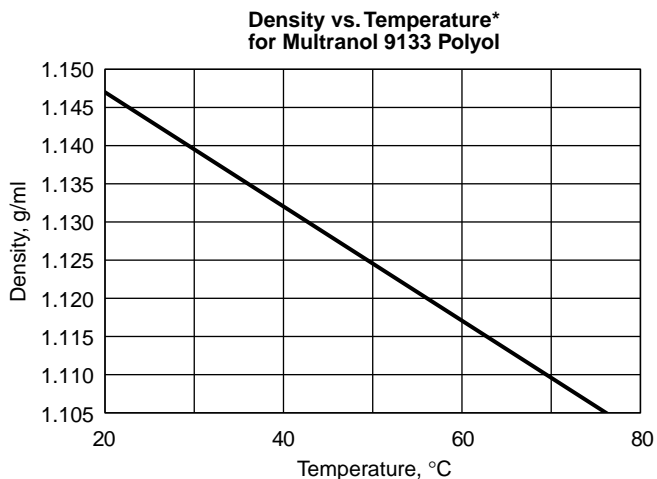
This polyol can become quite viscous at low temperatures. For ease of handling, storage temperatures between ambient room temperature and 49°C (120°F) are recommended.
