### Description

Multranol 9144 is a 1,100-molecular-weight amine-based polyether triol that is used in the production of specialty elastomers, adhesives, and reaction injection molded parts. ### Storage

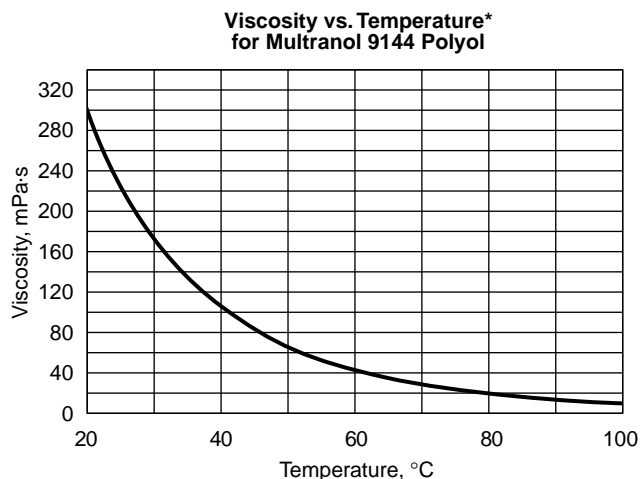
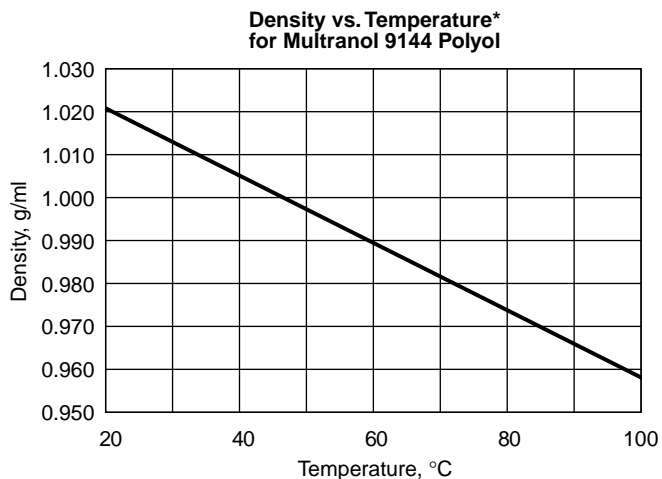
Multranol 9144 polyol is slightly hygroscopic and may absorb water. Containers should be kept tightly closed and protected from contamination with moisture and foreign materials, which can adversely affect processing.

This polyol can become quite viscous at low temperatures. For ease of handling, storage temperatures between ambient room temperature and 49°C (120°F) are recommended.
